- Transportation : Own arrangement.
- Accommodation : Own arrangement.
- Visa : VISA exemption for nationals of Thailand holding an ordinary passport
If the visa is needed, TAT will issue a letter to the Embassy of Argentina in Bangkok to facilitate the visa application.
- Participation Fees : 15,000 Baht (1 participant / company).
- Application Period : 10 August – 8 September, 2017

Application Conditions

1. For FIT2017, the reserved space for the Thailand Stand will be able to accommodate 4 companies.
2. Participants from each company must not exceed ONE person.
3. All participants will travel at their own expense (air ticket, accommodation, transportation, visa, etc.)
4. All sections of this application form must be completed.
5. The tourist business license or hotel business license is needed to submit for completing the application process before the status will be confirmed.
6. The application form is strictly treated on a first-come-first-served basis and will only be considered complete when the participation fee is paid.
7. Once you have paid the participation fee, please submit evidence of payment to TAT by e-mail.
8. The application deadline is on 8 September, 2017. However, TAT reserves the right to end the application process when the space is fully booked.

9. In case space is still available, TAT reserves the right to end the application process 5 weeks prior to the function in order to have enough time for preparation.
10. No refund of participation fees and no change of the participant's name after 8 September, 2017.
11. Please note that the provided information will be treated as confidential and is used for internal reference ONLY.
